Mr. Bob Chouinard, Assistant Principal, Cibola High School, stated he worked for the City of San Diego for many years overseeing youth programs. That experience drove him to education and he loves his profession. Mr. Chouinard is a certified jet ski mechanic.

Mrs. Badone commended Ms. Mary Lynn Coleman for her many years of dedication and hard work for the district. Ms. Coleman was also congratulated for being the recipient of the Dwight Patterson Alumna of the Year Award from NAU.

Mrs. Cordery was commended for her work and dedication. Mrs. Badone stated that because of her continued participation in difficult decisions and leadership the district once again received the Certificate of Achievement for Excellence in Financial Reporting Award.

Mrs. Honeycutt introduced the District Career Technical Education Counselors and the 3C Expo. CTE Counselors are Mrs. Johnston, Gila Ridge; Ms. Padilla, Vista; Mrs. Munoz, Kofa; Ms. Lofton, Cibola; Mrs. Eatherly, Yuma; and Ms. Heil, Arizona Western College. The role of the CTE Counselor is to be the liaison between the CTE program, Administrators, Consortium, and their Counseling Team. Counselors facilitate the dual enrollment for the high school students at AWC, promote CTE to all students, and advocates for CTE.

The 3C Expo: CTE, College & Careers event, was held on January 31, 2014 at Arizona Western College. The event involved nearly 1,000 eighth graders from twelve middle schools across Yuma County. Yuma Union High School District and Arizona Western College Career and Technical Education staff, counselors and students partnered with local businesses and non-profit organizations to provide Yuma County eighth grade students an experience of exploring, discovering and learning about a wide variety of career choices. They also had the opportunity to tour the Arizona Western College campus.

The 3C Expo planning team included Yuma Union HSD counselors and the Arizona Western College Coordinator of Admissions, Recruitment & Outreach. The planning team was invited to present at the Arizona School Counselors Conference held in March, and at the Arizona Career and Technical Education Summer Conference in July. Counselors gave an overview of their presentation.

Mrs. Cordery stated the District is at 4% for Maintenance and Operations and 2% for Capital. There were no questions from the board.

Mrs. Badone stated that the school year was off to a great start with 10,962 students enrolled. The most recent updated district profile was shared with the Governing Board with the

There are several new systems this year. The first is the Illuminate Ed Student Information System, which is essential to all of the district's functions of tracking students for the purposes of attendance, academic achievement, credits, programs, scheduling, teams and clubs, as well for reporting to the State of Arizona SAIS system. In addition, there has been a new bookstore software system and online webstore for the ease of collection of fees as well as tracking resources checked out to student like netbooks. The third software implementation was the new Learning Management System (LMS), Canvas. Canvas is a platform through which teachers can upload everything related to their courses, and students can access the resources for the course throughout the platform as well.

Mrs. Badone reviewed Blackboard Connect, the continued Netbook, and Cambridge IGCSE Curriculum Implementation. There will also be a focus on specific project goals by the following committees: Technology, Calendar, Supplemental Salary, and Student Fees.

Mrs. Badone reported that Yuma Union High School District and Antelope Union High School District were in the process of developing the election documents for the November 4, 2014 Special Election. The districts have completed the ballot language, information section of the pamphlet, and posted in the Yuma Sun and website with the legal notice. The election pamphlet will be sent to voters the beginning of October by Yuma County Election Services. Final proofs of the informational pamphlet will most likely be available at the following board meeting.

The estimated costs for the special election are approximately \$62,000. Mr. Townsend inquired on the preparation needed for the selection of the two members who will be appointed to the JTED board, if the ballot measure passes. Mrs. Badone said it would be a future agenda item, possible discussed with Mr. Tom Tyree.

The election calendar of events and the documents were shared with the Governing Board.

Mr. Sheldahl stated that their had been many benefits to the partnership with the Helios Foundation. One of the benefits has been funding being provided for projects that the district did not have the resources for. During the Spring of 2014, a Market Research Study was conducted regarding Ready Now Yuma. Helios Education Foundation funded the study as part of the additional grant monies allocated for community engagement and evaluation. An external company, WestGroup Research, was commissioned to conduct the study. The market research included parent focus groups, as well as phone surveys of parents and registered voters.

Matt Buckley, Director of Community Engagement and Communications, shared an overview of the data collected

- Awareness and understanding about education landscape, quality of education and student academic performance
- Personal/community prioritization of education and viewpoints about it as a strategic investment in Yuma County
- Awareness of importance of postsecondary education for all students and support of college-going expectations
- Awareness and support of Yuma Union High School District
- Awareness, understanding and perceptions of Ready Now Yuma and its goals
