The Indian Ed office is taking forms for Navajo School Clothing. The enrollment will close on August 24 at 4:00p.m. Parents/Guardians applying for the school clothing program need the child's height and weight, CIB on file with Indian Ed and the child needs to be on free or reduced lunch.

CI has allocated funds for one time assistance to students who are in need of clothing, hygiene or school supplies.
