 - High School Principal There are 58 boys out for football and 30 girls out for volleyball. The sports schedules are online. Very

- Jr. High School Principal Mr. Squires reports a good start to this year. Meet the Teacher night brought out 200 people. Cookies were served. A Welcome Back Dance was held on Thursday. JH sports scheduled will be placed online. Student council elections were held today. JH is staffed for the year. There are 130 students. The 7th period additional PE class is working out well.
