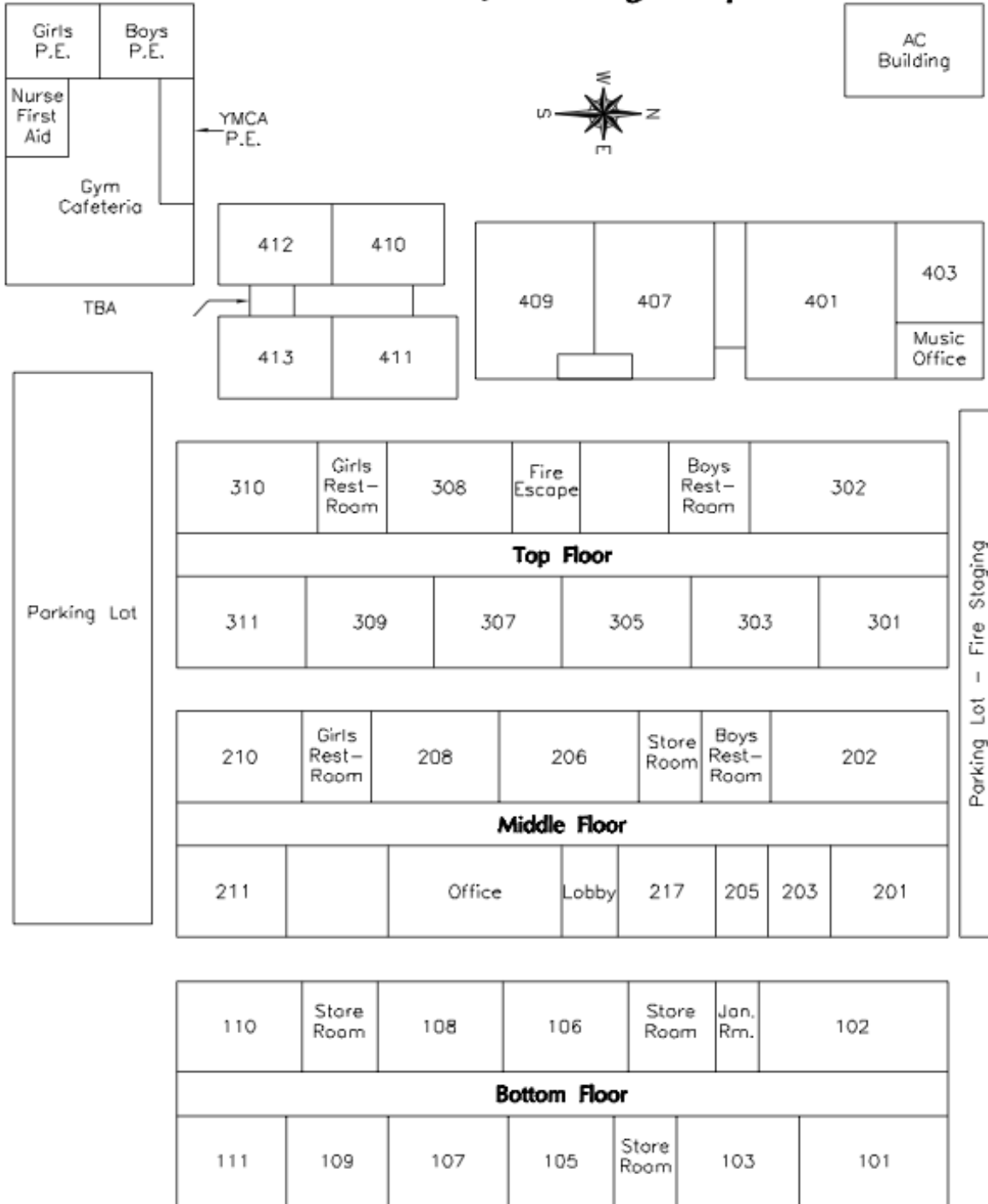

- A parent liaison will be provided to promote positive school to home communication, schedule additional parent/teacher conferences, and promote additional programs that may be beneficial to the families of Fourth Avenue.

**A middle school student must earn a cumulative grade point average (GPA) of 1.0 or better. A student must maintain a passing GPA in the core subjects of language arts, mathematics, social studies, and science to be promoted to the next grade.**

### **Closed Campus:**

Students are required to remain on campus from the time they arrive in the morning until they have been dismissed. Students are not to leave campus during school hours without parental and school consent. Students who are requested to leave campus early must be signed out at the office by a parent/guardian or an authorized adult.

### **Visitors:**

It is the obligation of the Principal's office to maintain a safe campus and to protect the health and welfare of students and staff. **All visitors on campus are required to check in at the front office for authorization to visit campus.** Students are not permitted to bring guests to school.

**\*\*\*Parents MUST show a valid and current ID when picking up students from school.**

**NO EXCEPTIONS.**

### **Prohibited Articles:**

All food and drink items including gum, sunflower seeds, candy, sodas, etc, are prohibited except when approved by the principal's office for an approved school function.

Tobacco, electronic cigarettes, alcohol, drugs, over the counter medication, inhalants, and prescription drugs. weapons, skateboards, Inline skates, blades, water pistols, markers, chains, laser pens, electronic devices, aerosol containers, and other items considered dangerous or unsafe are not permitted on campus.

### **Cell Phone/Electronic Devices:**

**School administration is not responsible to investigate the loss or theft of any electronic device.**

To avoid theft, loss, or damage, students should not bring valuable items to school unless such items are part of a class project or assignment.

### **Student Cell Phone Limitations:**

**Student cell phones must be off and put away during school hours.** If a student has a cell phone out in class, the cell phone will be confiscated and turned into the office. Any student found to be using a cell phone inappropriately or in a disruptive manner during school hours will have their cell phone confiscated and disciplined accordingly. Cell phones **MAY NOT** be out in the PE locker rooms. It is against the law to threaten, harass, or bully others with text messages/phone calls or by posting comments on Internet sites such as Facebook, Twitter, Snap Chat, etc. Our school Site Resource Officer (SRO- police officer) may be involved in these kinds of complaints. **Students bringing cell phones on campus do so at their own risk!**

### **Confiscated Items:**

Any confiscated items can be retrieved from the school office on Fridays from 12:00 PM to 3:30 PM. Items can **ONLY** be released to a parent of record. **There will be no exceptions to this policy!**

### **Drug Free School Zone:**

Fourth Avenue Junior High School has been officially designated as a **DRUG FREE ZONE**. Anyone, including students, found to be in possession of any illegal drug for use or distribution, is in violation of ARS 13-34-11.A-1 and is subject of enhanced legal penalties including a fine of not less than \$2000.00.



### **Safety Drills:**

Drills are unannounced but are held regularly during the school year to provide awareness of the warning system. The procedures are outlined and addressed with staff and students at the beginning of the year.

### **Attendance:**

**Parents are to notify the school office when a student is absent by 9:00 a.m. on the day that child will not be in school.** Any student returning to school without parental notification of an absence, such absence will be considered un-excused and will be subject to disciplinary action. Also, please notify the office and teachers when you have prior knowledge of a student being absent. **It will be the responsibility of the student to arrange for make-up work.**

#### **Example of excused absences:**

Personal illness      Doctor's appointments      Emergencies      Funeral services

#### **Examples of unexcused absences:**

Babysitting      Missing the bus      Oversleeping  
Car trouble      Out of town trips

**A student who CONSISTENTLY has unexcused absences will be subject to disciplinary actions. If an absence is reported as an illness repeatedly, a doctor's note will be required to keep this from being considered for disciplinary action...such as truancy.**

### **School Attendance Policy:** *Signed attendance policies will be kept on file*

By law, students are required to attend school every day, unless they are absent for an approved reason. Students who show a pattern of poor school attendance, or who have many unclear absences or trancies, will be referred to the **Yuma County Juvenile Justice Center** for intervention and/or for disciplinary action.

Excessive absences: A student must attend class regularly to receive a passing grade. A student who is absent from a class more than ten percent (10%) of the number of required attendance days, and whose absences have materially affected their academic progress, may fail that grade, receive a lower grade, or be retained.

### **School-Wide Discipline:**

A copy of the District Discipline Policies and Procedures is provided for each student for review by students and parents. Students who violate school and/or classroom rules will receive disciplinary action, which is appropriate for the particular offense. All efforts will be made to communicate with the parents to help prevent further misconduct by the students. It is the responsibility of the student to respect the right of others. Fourth Avenue Junior High has developed policies and procedures that govern student behavior.

### **Disciplinary actions may include the following:**

1. Verbal warning by teacher or administrator
2. Classroom consequences assigned by teacher
3. After school detention assigned by teacher or administrator
4. In-School Suspension, removal from the regular classroom assigned by administrator
5. Out-of-School Suspension assigned by administrator

Other consequences may be assigned at the discretion of the administration. Students may be prohibited from attending or participating in extracurricular activities as a result of misconduct.

### **Gangs/Secret Societies:**

It is the District's position that gangs/secret societies that initiate, advocate, or promote activities that threaten the safety or well being of persons or property on school grounds or that disrupt the school environment are harmful to the educational process. Further, it is the District's position that the use of hand signals, graffiti, or the presence of any apparel, jewelry, accessory, or manner of dress or grooming that, by virtue of its color, arrangement, trademark, symbol or any other attribute indicates or implies membership of affiliation with such a group is prohibited because of the disruption to educational activities. Any activity involving an initiation, hazing, intimidation, assault, or other activity related to group affiliation that is likely to cause or does cause bodily danger, physical harm, or personal degradation or disgrace resulting in physical or mental harm to others is prohibited and disciplinary action will be imposed accordingly.

## **FAJH School Uniform Policy**

The District encourages students to take pride in their attire as it relates to the school setting. In 2006, the Yuma School District #1 School Board approved a school uniform policy for Fourth Avenue Junior High School. The school uniform policy takes into consideration the educational environment, safety, health, and welfare of our students. Our FAJH school uniform policy is as follows:

1. **Shirts** – must be a **solid**, red polo style with a collar with 2-3 buttons max. Top button must be unbuttoned at all times. Shirts may be short or long sleeved. Sleeveless are not allowed. Pictures, words or logos are also not allowed on shirts unless it is a FAJH logo. Shirts may be tucked or untucked with the length limit at the wrist. Undershirts (if also worn) must be solid red, black, white or gray and cannot be longer than the shirt. Shirts may not be altered (clipped or tied back).
2. **Pants, shorts or skorts** – must be **solid** black. Length of skirts, shorts, and skorts must be below mid-thigh. If it is shorter, it will be considered a dress code violation. Pants, shorts or skorts must be worn at the WAIST at all times. Pants, shorts or skorts must be no larger than ONE SIZE more than the student's normal size. If a student's pants are excessively baggy and falling below the waist, this will also be in violation. Hems should not be frayed or drag on the floor. Shorts must be of the appropriate length-not shorter than the fingertips when arms descended down along the side of the body. Decorative stitching and/or designs on bottoms are not allowed. Pants cannot be ripped or torn. Again, all bottoms must be a solid black color. **Gym shorts, sweat pants, leggings, jeggings, or other articles of clothing deemed inappropriate by administration are not allowed.**
3. **All Belts** – must be a **solid** red, black, or white only. Belt buckles must be appropriate. Old English lettering, gang affiliation, drugs/alcohol related, cutout letters or initials will not be allowed. Belts should not be hanging from the belt loops.
4. **Sweatshirts, outerwear, and jackets** – must be **solid** red, black, white or gray. No decorative stitching, designs, symbols or writing are permitted.
5. **Gang related personalization** – is not permitted on items of clothing, backpacks, belt buckles or on one's person.
6. **Caps and hats** – are not allowed at school. Hoods on sweatshirts should not be worn inside any buildings, classrooms or cafeteria/gymnasium.
7. **Jewelry/Accessories** – that represents a safety hazard to self and others is prohibited. Watch and wallet chains are not allowed. Non-prescription, colored contact lens is not allowed.
8. **Shoes** – students must wear shoes at all times. No slippers or flip-flops allowed! No backless shoes.
9. **Socks**-must be worn properly, under the pants.

Any apparel that the administration determines to be unacceptable in light of school and/or community standards is prohibited. This includes but is not limited to clothing, which offends or disrupts the educational process.

In addition to the above guidelines, students who are involved in extra-curricular activities such as athletics, band, choir, etc. are subject to the standards of dress as defined by the sponsors of such activities.

We reserve the right to allow no uniforms on special occasions. Students and parents will be notified on these dates.

### **DRESS CODE POLICY** (The following will not be allowed)

- Hats, baseball caps, gloves, hair net, beanies, doo-rags, and bandannas will not be allowed on school campus.
- Excessively baggy, loose fitting clothing is not allowed.
- Spaghetti straps, tank tops, or excessively low cut shirts are not allowed.
- Gang-related personalization is not permitted, on items of clothing, belt buckles or on one's person. Bandannas and any belts hanging from the pant loops are prohibited as well as any simulation of anything representing "colors." Any clothing, which would identify a student as a gang member, **will not be tolerated.**
- Sunglasses cannot be worn inside the buildings
- Profane, obscene, or defamatory language or symbols, ethnic slurs, or symbols of drugs, sex, gang or alcohol on clothing or jewelry will not be allowed. Also, wallets with chains are prohibited on school campus.
- If body piercing becomes a distraction, a parent conference will be required.
- Bare feet, flip-flops or slippers are never acceptable.
- Students who volunteer for extracurricular activities, such as athletics, band, choir, etc. are subject to the standards of dress as defined by the sponsors of such activities.

#### **Consequences:**

**When a student is in violation of the dress code and uniform policies, the teacher will send the student to the office with a General Pass filled out with the dress code or uniform policy violation information.**

-Student will be required to change clothes and/or place a call home to parents.

#### **Field Trips:**

Field trips are a privilege, and are related to your class work. However, if your behavior, grades and/or attendance are a concern, you may not be allowed to attend a field trip.

#### **Extra-Curricular Participation When Absent From School:**

Students absent from school may not participate or attend extra-curricular activities such as athletic practice, contests and events, meetings, rehearsals, practices of any kind, dances, try-outs, and performances. Students with an excused half-day absence may participate/attend.

#### **Counseling Services:**

The counselor is a source of a wide variety of information, a helper, a friend, an advocate and someone in whom students can confide. It is best to sign up in the office to see the counselor, but in emergencies, students may ask their teacher for a pass to the counselor's appointment will not interfere with work in class.

### **School Dances:**

All rules governing the campus apply to the student dances. Additional rules and procedures will be issued and distributed to students and parents prior to the dance. Dances are from 6:00-8:00 P.M. Attendance at school dances is conditional upon student behavior and attendance.

Misconduct or absences may result in a student not being allowed to attend a dance. **Students not picked up promptly at 8:00 PM will not be permitted to attend the next dance.**

### **Cafeteria:**

A breakfast and lunch program is provided to all students. Menus are displayed in the cafeteria and around the school. Students are required to conduct themselves in a safe and orderly manner, maintain cleanliness, and show proper courtesies to their fellow students and school employees.

### **Library:**

Students are expected to respect the rights of others by behaving according to school/library rules, promptly returning books borrowed, and paying for damaged or lost books.

### **Health Office:**

The school health office is open during school hours to provide health information, dispense physician/parent-approved medications and provide first aid to students. The health aide should always be consulted in cases of injury during the school day. The health aide is the only person authorized to permit a student to go home during the school day due to illness.

**Prescription medications may be administered by the health aide only under the following conditions:**

- (1) The medication has been prescribed by a physician for that student.
- (2) The medication must be in its original container and kept in the nurse's office during the school day.
- (3) No medication from Mexico shall be dispensed at school unless it is accompanied by the original prescription from a licensed physician, nurse practitioner, physician's assistant, or dentist licensed in Arizona or California. Medications prescribed by a physician, etc. licensed outside of the United States cannot be brought to school.

In order for the health aide to administer over-the-counter, non-prescription medications, the medication must be in the original container and a parent permission note must be on file in the nurse's office. Students are not allowed to carry non-prescription medications on campus.

### **Transportation:**

Public school transportation services are a privilege, not an entitlement. Continued transportation service is contingent upon student compliance with school bus rules. These rules are in place to promote the safety of all students granted the privilege of riding a Yuma Schools Transportation Department Bus. Failure on the part of the students to comply with the school bus rules could result in permanent loss of riding privileges for the school year and disciplinary action from the school up through expulsion. # iPad Oath
