Mrs. Rutkowski moved to approve the Consent Agenda. Mrs. Stock seconded the motion. The motion was approved with a vote of 5-0.

#### **Information/Discussion Items** - None

A brief addition to Policies BEC – Executive Session, BEDA – Notification of Board Meetings and GCQF – Discipline, Suspension and Dismissal of Professional Staff Member provides districts with

more clarity and direction in the posting of notices and eliminates some potential confusion in the timeline allowed for an employee to request an open hearing.

Policy BEDH – Public Participation at Board Meetings is modified to insure compliance with A.R.S. 38-431.01(H) pertaining to Open Meeting Law.

Policy IKE — Promotion and Retention of Students states that a student's high school grade classification may be determined by each district as the definition included in the policy is neither in statute nor in the State Board of Education rules. ASBA Policy Services has explained that student promotion to a higher grade at midyear is permissible and is referenced in regulation IKE-RB. The Attorney General has opined in I84-016 the following: "A student may be promoted to more than one grade higher than his present grade. A teacher may promote a student at any time during the academic year." Therefore, a district may determine the specific procedure(s) to document and standardize a midyear/early promotion action.

Policy IKF – Graduation Requirements includes several updates due to the repeal of A.R.S. 15-701.02 (Alternative High School Graduation Requirements) and the removal of references to this statute and R7-302.09 (AIMS, Additional Credit, Augmentation) from the Manual.

Policy JFAB – Tuition/Admission of Nonresident Students removes a paragraph pertaining to the admission of students who are United States residents but nonresidents of the state and designates any action of the Governing Board as discretionary, not mandatory.

Policy JK – Student Discipline has been altered by moving some language and modifying a heading title in order to eliminate the assumption that everything that follows in this document pertains to special needs students. Clarification has been added to communicate the rules pertaining to discipline, suspension, expulsion, and the provisions pertaining to confinement of pupils to students at the beginning of each school year, and to transfer students at the time of their enrollment in school.

#### Action

Mrs. Rutkowski moved that the Board approve the Carl Perkins Program Intergovernmental Agreement (IGA) for the 2015-2016 school year. Dr. Wright seconded the motion. The motion was approved with a vote of 5-0.

Mrs. Stock moved the Board approve the FHHS Falcon Music Department trip to Anaheim, California on April 6 - 10, 2016. Dr. Barnard seconded the motion. The motion was approved with a vote of 5-0.
