A regular meeting of the Governing Board of the Fountain Hills Unified School District #98, Maricopa County, was called to order at **6:30 p.m.** at the FHUSD Learning Center, 16000 E. Palisades Blvd., Fountain Hills, Arizona.

Board Members in attendance were: Jill Reed, President; Edith Stock, Vice President; Dr. C.T. Wright; Judith Rutkowski, and Dr. Wendy Barnard

Mrs. Rutkowski moved the Board approve the agenda with addendum. Dr. Wright seconded the motion. The motion was approved with a vote of 5-0.

Mrs. Reed called upon Mr. Karl Ivarsson to lead the audience in the Pledge of Allegiance.

- **a. Superintendent Comments** Dr. Patrick Sweeney
 - Congratulations to Dr. Paul McElligott for being selected as the 2015 Teacher of the Year. On November 12, Dr. Paul will be presented his award at the Governor's Celebration of Innovation. At that time he will showcase his innovation with a display using photos and text to describe his teaching style and how it is innovative; mentoring and support of both students and teachers; and development and support of STEM competitions.
 - Dr. Sweeney has been visiting FHUSD classrooms and is impressed and applauds our teachers for creating a positive learning environment.
 - The ACT readiness reports show the highest scores in five (5) years. These scores are also higher than the state average.
