Dr. Wright moved the Board approve the agenda with removal of Information/Discussion Item 9 a.(Revisions to Policy GCO). Mrs. Rutkowski seconded the motion. The motion was approved with a vote of 4-0.

## **Public Hearing on the Budget:**

Mrs. Rutkowski moved the Board suspend the regular meeting and conduct a Public Hearing on the Budget FY 2015-2016. Dr. Wright seconded the motion. The motion was approved with a vote of 4-0.

Mr. Lawrence reviewed the 2015-2016 Budget, which has been available on our website for public review as required by statute. The three areas of the budget that are formula driven are the Maintenance and Operations Budget, the Capital Budget, and the Classroom Site Fund. There are other parts of the budget that are unknown at this time, such as the cash accounts and special programs. The budget capacity on those accounts was projected and will be updated throughout the year. He reminded the Board that the budget may be revised throughout the year. There were no questions from the Board or the Public.

Dr. Barnard moved to close the Public Hearing and reconvene the regular meeting. Dr. Wright seconded the motion. The motion was approved with a vote of 4-0.
