### **Information/Discussion Items**

The **FHHS Photography/Art Club** is requesting permission for an extracurricular trip to Paris during Fall Break 2016 (week of October 10). The students will study and absorb the history and culture of Paris through seeing its art, architecture, geologic features, and experiencing its music and dance.

Principal Dehombreux presented changes to **Regulations JEB-RA and JEB- RB – Entrance Requirements**. Both regulations address early-entry procedures for Kindergarten and First Grade. Both regulations will include a two-step process instead on just one step.

Because of the timeline and deadline for the budget to be approved by July 15, a short board meeting with a public hearing is necessary in July. The only item on this agenda will be adoption of the 2016-2017 budget. Administration is suggesting **Wednesday**, **July 6 for this meeting**.

It has been our practice to schedule **Board meetings** on the second Wednesday of each month. Meetings are scheduled on the fourth Wednesday of the month for pending business or Study Sessions. There are two exceptions to this schedule: The October meeting will be held on the  $4^{th}$  Wednesday (October 26) of the month due to Fall Break; and the May meeting will be held on the second Tuesday of the month (May  $9^{th}$ ) due to Senior Recognition scheduled for May  $10^{th}$ .

#### Action

Mrs. Reed moved the Board **approve the Term Sheet Agreement** giving Crown Castle 120 days to conduct a review of the current cell tower site. If, at the end of the 120 day period, Crown Castle decides to proceed, the parties would execute a Grant of Easement document to be approved by the Governing Board. Mrs. Stock seconded the motion. The motion was approved with a vote of 5-0.

Dr. Allen explained and reviewed each revision to the Revised Budget. Dr. Barnard moved the Board approve **the Revised Budget 2015-2016.** Mrs. Stock seconded the motion. The motion was approved with a vote of 5-0.

Mrs. Stock moved the Board **award the Superintendent a performance based compensation of 5%** for the 2015-2016 school year. Mrs. Rutkowski seconded the motion. The motion was approved with a vote of 5-0.
