ELECTRONIC INFORMATION SERVICES USER AGREEMENT

The District may provide Electronic Information Service (EIS) to qualified students who attend Jeddito School. Electronic Information Services include District networks, the internet, databases and any computer—accessible source of information whether from hard drives, tapes, compact disks (CD's), floppy disks or other electronic source.

Please read this document carefully. When signed by the user, this document becomes a binding agreement. You will not be permitted to use the computers until you sign, date and submit this document to the school office.

TERMS AND CONDITIONS:

- I will use the EIS for educational purposes only.
- I will not submit, publish, display, or retrieve any material forbidden by statutes, laws or district policies and regulations, including that which is defamatory, inaccurate, abusive, obscene, profane, sexually oriented, threatening, racially offensive, or illegal...
- I will abide by the Cedar Unified School District #25 policies and procedures while using the EIS.
- I will report any misuse of the electronic information resources to a parent, teacher, or the system administrator as appropriate.
- I will not use the network in any way that would disrupt us of the system by others.
- I will not reveal home addresses and phone numbers of others or myself.
- I will not attempt to learn the passwords of other users or give passwords to others.
- I understand that electronic mail is not private.
- I will strive to use correct spelling, punctuation and grammar when sending electronic mail or publishing documents.
- I will take responsibility for any account that is given to me, and will keep my password and/or user ID private.
- I understand that many services and products available through EIS may be available for a fee and acknowledge the responsibility for any expenses incurred without District authorization.
- I understand Cedar Unified School District #25 specifically denies any responsibility for the accuracy of information. While the District will make an effort to ensure access to proper materials, the user has the ultimate responsibility for how the EIS is used and bears the risk of reliance on the information obtained.
- I understand that Cedar Unified School District #25 does not assume liability for any information lost, damaged, or unavailable due to technical and/or other difficulties.
- I understand that Cedar Unified School District #25 reserves the right to establish rules and regulations as may be necessary for the efficient operation of the EIS.

I have read and understand the Electronic Information Services User Agreement. I agree to abide by the Cedar Unified School District policy and regulations on appropriate use of electronic information services. I understand that it is impossible for the Cedar Unified School District to restrict access to all controversial material; therefore I will not hold the District responsible for materials accessed by the use of the information services. I agree to report any misuse of the information services to a School District Administrator. Misuse can come in many forms, an example of misuse would be any messages sent or received that suggests pornography, unethical or illegal solicitation, racism, sexism, inappropriate language, or other issues described in the agreement.

IMPORTANT NOTE: You and your class will not be permitted to use computers until you have signed, dated and submitted this document to the administrative office.

I understand that any violation of the terms and conditions may result in disciplinary action and the revocation of my use of electronic services.
