CALL TO ORDER

The Cedar Unified Regular School Board Meeting was called to order by

Francis Ambrose arrived at 5:49 p.m.

Ladybird Jack. Motion carried with 3 votes in favor, 0 opposed and 0

abstentions.

with 3 votes in favor, 0 opposed and 0 abstentions.

SUPERINTENDENT'S REPORT

#### 1. Calendar of Events

Mr. Noggle informed the board about the events happening in September and October and what is happening at the school. He stated that he and Delores Noble attended the Law Conference and was very informative. He stated that the focus this year was on transgender issues, open meeting law, and superintendent's reports. They were told that basically what the superintendent can put in his report is a calendar of events. If there is anything else a board member wishes to speak on, it needs to be an agenda item. He also stated that we did promethean board training for the teachers on Friday morning and held Parent/Teacher Conference in the afternoon. The training went well and we are planning to schedule another one as we are focusing on using technology in the classroom. We didn't have as good a turnout for Parent/Teacher Conference as we did for Open House, but he believes it was due to other events taking place in the area. Mrs. Noble, Federal Programs Coordinator had her first Title I Parent meeting and only 3 parents showed up. Of the three parents, they elected a President, Vice-President and Secretary/Treasurer. Mrs. Noble is in charge of JOM and Title I. Mr. Noggle informed the board that two board members are

registered to attend the ASBA County Workshop on Wednesday, they are Iris Yessilth and Francis Ambrose. He won't be attending the county workshop but will be attending the meeting with C. Diane Douglas, State Superintendent at Hopi Mission School. He was asked to be a panelist and he will mention the difficulty we have in infrastructure and roads. He is working with a grant writer to get funding for the school for roads and security issues. He stated that dogs and horses are an issue on campus. Mr. Noggle informed the board that he will be attending an RSNA meeting in Flagstaff next month, the end of the first quarter is October 6<sup>th</sup>, we have Staff Development on October 7<sup>th</sup> and we have results from the Galileo assessment which we will share at the next board meeting. Our next regular board meeting is October 12<sup>th</sup> and it is very important we have a quorum as Bonnie Haven will have the Annual Financial Report that must be submitted by October 15th. Mr. Noggle invited the board to attend the student awards assembly on October 13th, this is where the students will get awards for honor roll, perfect attendance, Student of the Month and the teachers will have individual awards as well.

**NEW BUSINESS** 

A. Discussion and Possible Action on RSNA Resolution Authorizing Duane Noggle as District Representative and Bonnie Haven as Alternate Representative for SY2016-2017

Danny Sage motioned to approve the RSNA Resolution authorizing Duane Noggle as District Representative and Bonnie Haven as Alternate Representative for SY2016-2017. Motion seconded by Ladybird Jack. Motion carried with 3 votes in favor, 0 opposed and 0 abstentions.

#### B. Discussion and Possible Action to Suspend Board Policy GDD, Support Staff Vacations and Holidays per board Policy BGF, Suspension/Repeal of Policy

Mr. Noggle informed the board that we are having employees, namely 12-month employees trying to use their leave that they can't carry over in a crucial time when students are here. He is requesting to give them time to use their leave over Fall Break or Winter Break this year.

Danny Sage motioned to approve to suspend board policy GDD as presented. Motion seconded by Ladybird Jack. Motion carried with 3 votes in favor, 0 opposed and 1 abstention. Francis Ambrose abstained.

### C. Discussion and Possible Action to Approve the Revised Teacher Evaluation Instrument

Mr. Noggle informed the board that Arizona state law changed sometime ago where you must include student performance in the teacher evaluation based on data. The state sets the formula. He stated that the evaluation used last year was not board approved that he can find, and the one that was board approved in 2012 does not have that formula in place. Mr. Noggle explained to the board the percentage of the evaluation based on student or classroom performance of highly effective, effective, developing or ineffective. A teacher has to have 40 points and half has to come from student achievement. He stated that this year we will use benchmarks from Galileo, diebels and journey assessments as opposed to AZmerit assessments, which is based on last years' teaching staff. Mr. Noggle stated that once the board approves it he will begin teacher evaluations.

Danny Sage asked if a teacher is not performing is there an improvement plan in place. Mr. Noggle replied that yes, we will still follow policy where if a teacher is rated ineffective or even developing it would require an improvement plan. A teacher has to be highly effective or effective. On the teacher evaluation there is a self assessment in place where they would establish an improvement plan for themselves regardless. Iris Yessilth asked how many evaluations does a continuing and non-continuing teacher have. Mr. Noggle replied that he will do a minimum of two observations and two classroom walk throughs for non-continuing teachers and a minimum of two observations for continuing teachers. Francis Ambrose asked if the Prop 301 monies are tied to the evaluation process. Mr. Noggle replied that they will be revising that plan and will come back to the board for approval. He stated that one thing he is looking at changing is in order to receive the Prop 301 monies a teacher needs to be highly effective or effective. Francis Ambrose had another concern regarding the evaluation

instrument, does this evaluation tool have a copyright attached to it. He didn't feel that the school could adopt it if it does have a copyright.

Danny Sage motioned to approve the revised teacher evaluation instrument as presented. Motion seconded by Ladybird Jack. Motion carried with 4 votes in favor, 0 opposed and 0 abstentions.

# D. Discussion and Possible Action to Approve the MOU between Cedar Unified School District #25 and Winslow Indian Health Care Center's Methamphetamine and Suicide Prevention Initiative Program (MSPI)

Danny Sage asked if Legal Counsel reviewed this MOU, Mr. Noggle replied no, it can be cancelled at any time, all it asks for is a facility and cooperation. They will be getting consents from parents. No financial obligation to the district.

Danny Sage motioned to approve the MOU Between Cedar Unified School District #25 and Winslow Indian health Care Center's Methamphetamine and Suicide Prevention Initiative Program (MSPI). Motion seconded by Ladybird Jack. Motion carried with 4 votes in favor, 0 opposed and 0 abstentions.
