This meeting was held at the Willcox High School Office.

1. Move new baseball field north to avoid conflicts with neighborhood.
2. Replace softball field with artificial turf and sports lighting.
3. Pitcher's mounds at baseball and softball fields should remain dirt/clay mix.
4. Undisclosed backer willing to match the amount of money that the school district had bonded for.
5. At the existing gym:
 - a. Replace evaporative cooling with air conditioning.
 - b. Remodel existing locker rooms and fitness rooms.
 - c. Remodel existing public restrooms. Perhaps extend building east to increase size of restrooms.
6. Replace existing wrestling room building with block construction.
7. Provide new restroom / concessions building at new softball field for the softball, soccer field & tennis court use.
8. Provide artificial turf at the infield of the JV baseball field.
9. Improvements to the gyms and fields could produce additional revenue by hosting competitions. This revenue could offset costs for future maintenance of the artificial turf and all weather track.
10. Artificial turf is available in different grades which will determine when the product needs to be replaced.
11. Lockers at the new gym building are all to be half height lockers. Provide stamped diamond ventilation holes on the door face. Color of lockers to be Relay Red #721.
12. Colors on the exterior of the building to match the two story building.
13. Colors on the interior of the gym to match colors of the two story building with the exception of the ceramic wall tile colors. The gray color should be substituted with "Urban Putty".
14. Take credit for ceramic mosaic floor tile in the staff restrooms. Provide sealed concrete instead.
