LASSITER HIGH SCHOOL 2015-16 STUDENT/PARENT PARKING CONTRACT

Safe, orderly and responsible operation and parking of cars on campus is essential to the welfare of all concerned. We earnestly seek your support of and compliance with all traffic-related Board of Education policies and regulations. IT IS UNDERSTOOD THAT:

1. Students are assigned a numbered decal for parking on campus. Students must park only in assigned lots (map will be given with decal). Park where you're not obstructing any other driver. Each car parked on campus in a semester has to have a decal- 1^{st} decal-50; 2^{nd} vehicle decal-55 (which may be driven by the student only).

IMPORTANT Students cannot park on campus during the school day without a 1^{st or} 2nd Semester 2014-15 decal as required by Board of Education Policy and District Regulations. They will get a citation if found-1st Offense-\$10 citation +\$1 per school day until paid; 3rd Offense-\$30 citation +\$1 per school day until paid; 4th Offense-car will be towed at student's expense. All citations will increase \$1 per school day from the date of isse if left unpaid until the ticket amount has doubled.

2. <u>Students will purchase a 1st and 2nd semester parking decal at beginning of each semester</u>. <u>Parking decals are</u> <u>not transferable from one car to another or from one individual to another</u>. Motorcycles must have a parking decal also – although they may be assigned to a common parking area.

3. Students can <u>only</u> register a car owned/leased by them or their family and that is legally registered in Georgia. Students may NOT register a car for another student using their name. The penalty is voiding the permit. The school will not refund the cost of the permit.

4. The School District retains all rights to all parking spaces. In selling a parking permit, the School district only grants permission for a student to park his/her REGISTERED car. Students MAY NOT share, resell, trade, loan or give away an assigned parking permit to anyone-this will result in the voiding of the parking permit (with no refund given). Appropriate disciplinary action, including ISS, OSS, or explusion will be taken by school officials.

5. A student using an automobile to store, transport or conceal contraband (drugs, alcohol, tobacco, dangerous weapons or anything else illegal under the laws of the State of Georgia or forbidden by Board of Education policy) on Board of Education property, or on any other property while the student is attending a SCHOOL-SPONSORED event, will result in the voiding of the parking permit. Appropriate disciplinary action, including ISS, OSS, or explusion will be taken by school officials.

6. Any student who is suspended out of school will have his/her parking permit voided for a minimum of 45 school days with a maximum of time being for the remainder of the school year or possibly permanently. The school will not refund the cost of the permit.

7. <u>AT NO TIME CAN STUDENTS PARK IN VISITORS OR FACULTY DESIGNATED</u> <u>AREA OR IN NO PARKING AREAS ON CAMPUS (INCLUDING BUS LANES). The</u> <u>front drive and all concrete areas around the building (including area outside gym)_are No Parking Zones. AT</u> <u>ALL TIMES, day or night, and on weekends, these areas must be kept clear for maintenance, emergency and other</u> <u>authorized vehicles 24 hrs. a day. The penalties for violation of this regulation are: 1st Offense-citation; 2nd</u> <u>Offense-voiding of permit and impounding of car. Failure to respond to citation is grounds for voiding permit as</u> <u>per Board of Education Rules and Regulations on back of parking permit application. The school will not refund</u> <u>the cost of the permit.</u>

8. The campus speed limit is 15MPH. Violations will result in citations, voiding of permit (with no refund given), citation to State Court and/or appropriate action. Students are expected to drive safely.

9. Any student who illegally leaves, or attempts to leave, campus or illegally transports another student off campus without following proper procedures will be given ISS or OSS, and your parking permit will be revoked for a minimum of 45 school days or you will lose parking privileges for a minimum of 45 school days, <u>even if you are a</u> <u>passenger in the car</u>. You are responsible for any parking violations committed by other students using your vehicle. The school will not refund the cost of the permit. This regulation applies to all student drivers, including those who are "absent", "checked-out", and/or in an "early release" program.

10. *IMPORTANT* If a student accumulates six (6) or more unexcused tardies or seven (7) or more unexcused absences in one semester, he/she is not eligible to purchase a parking permit the following semester UNTIL 45 SCHOOL DAYS FROM THE LAST OFFENSE. If a student has one or more tardies in the current semester when he/she purchases a permit, once six (6) unexcused tardies are accumulated, the student will have the permit revoked and the school will take further action as set by school regulations.

11. Any student suspended from school for ten (10) or more days may have his/her parking permit voided for a minimum of 45 school days and a maximum of student's attendance while at Lassiter High School.

12. <u>ANY STUDENT WHO PARKS IN FACULTY OR VISITORS AREA WILL BE GIVEN A CITATION AND THEIR CAR WILL BE SUBJECT TO BEING TOWED. WE WILL GIVE NO FURTHER WARNING OTHER THAN THESE EXISTING REGULATIONS.</u>

13. Falsification of ANY information on a parking permit application and/or forgery of any signature on said application will result in school officials' voiding of the parking permit (with no refund given). The school will not refund the cost of the permit.

14. For the safety of the school, any vehicle entering this campus is subject to a complete search by school authorities and law enforcement personnel assisting them. Such search may be conducted without warning for any reasonable purpose. Following the search, the vehicle will not be permitted to leave the premises without permission.

WE HAVE READ AND UNDERSTAND THE TERMS SET FORTH HEREIN. WE UNDERSTAND THAT THIS CONTRACT MUST BE SIGNED BEFORE A PARKING PERMIT CAN BE ISSUED AND THAT COMPLETION OF THIS CONTRACT, ACCOMPANYING APPLICATION AND NOTIFICATION OF TRUANCY FORM WILL BE CONSTRUED AS ACCEPTANCE OF ALL PARKING AND OPERATION RULES AND REGULATIONS.

Ineligibility and Revoked Decals

Ineligibility of revoked decals for parking is based on the following (Please initial ALL lines below)

_____Six unexcused tardies to school or class

_____Unpaid tickets or unauthorized transfer of parking decals

Traffic violations in school zone (speeding over 15 mph, not yielding, reckless driving, etc)

_____Person with a parking decal who is in possession of our usage of drugs, alcohol, or weapons in your vehicle, your parking decal will be revoked for the remainder of the semester

Leaving campus without permission (45 days or remainder of semester)

_____All drivers must follow directions of teachers, administrators or Campus Police Officer
