# TUITION RATES, CREDITS, AND FEES 2017 - 2018

### **TUITION**

Students (PreK-8) Catholic Rate\*\* Non-Catholic Rate
Per child \$ 6,350\* \$ 8,450\*

The projected per pupil cost to educate a child at St. Mary's School of Piscataway for the 2017 - 2018 school year is \$8,500.

#### **CREDITS**

Your Tuition Rate reflects a textbook funding credit per student from the State of Maryland.

#### **FEES**

Application Fee........\$50 per child (new students, non-refundable – Due with application on TADS)

 $Registration\ Fee......\$350\ per\ child\ (non-refundable-Due\ with\ registration\ on\ TADS)$ 

8<sup>th</sup> Grade Fee.....\$100 per child

All required fees must be paid on TADS, which is a prerequisite for enrollment at St. Mary's of Piscataway

## BEFORE AND AFTER CARE

1 CHILD......\$350 per month paid to TADS

2 CHILDREN.....\$500 per month paid to TADS

3 CHILDREN.....\$550 per month paid to TADS

4 CHILDREN.....\$600 per month paid to TADS

BAC Hourly Option is available to families who will not use the BAC service every day. Registration is still required for the BAC Hourly Option.

BAC Hourly Option Rate = \$8 per hour

- ➤ BAC Registration: \$75 per family, Non-Refundable Due with BAC Registration on TADS
- > No child will be permitted to attend the St. Mary's Piscataway BAC program without registration per the Prince George's County Childcare Regulations.

All tuition and educational/activity fees will be collected by TADS Management Company. Options for payment are automatic debit, credit card, or check (mailed to TADS). Each family will set up their individual TADS account online.

No payments will be made to the school.

<sup>\*\*</sup>Families must be active in a Catholic parish, attend Mass weekly and participate in the life of the community of faith. In order to maintain the highest standards in our school and to keep our tuition affordable, each school family that is registered at St. Mary's Church of Piscataway is required to attend Mass and make use of the weekly contribution envelopes. A family that is registered at another Catholic parish must provide a *Letter of Good Standing* from their pastor to be submitted with the Financial Agreement.
