Any family that has a prior year balance will not be allowed to register until the balance is paid in full. The Enrollment Contract must be completed, signed and returned with the registration fee no later than May 1, 2015.

TUITION RATES

Tuition rates for families are set according to the definitions as listed in the family handbook. The criteria for these rates are set by the Parish, not by the school. At the beginning of each school year, there is a small increase in tuition.

ACTIVE PARISHONER RATE

(Criteria set by the Parish)

To be considered active parishioners of St. Bede Parish, families are expected to use their time, treasure and talent to support the Parish by financially supporting the Parish (a minimum of \$40.00 per month) in the first plate collection through the twelve (12) month calendar. Parish contributions are tax deductible.

To qualify for this rate, families must be registered and participate actively in the life of St. Bede Parish, this will be regularly confirmed by the Parish.

If participation in Parish services and ministries cease, tuition payments will change to the Catholic rate.

TUITION PAYMENTS

Tuition payments are due on the first of each month and considered late after the fifteenth of the month. A five-day grace period will be allowed. After the 20th of the month, a non-reversible late fee of \$35.00 will be assessed.

Additional payment options may be available. Please contact the Bookkeeper for additional information. Payments must be sent directly to St. Bede Catholic School. Payments can be mailed or paid in the school business office. Payment methods are as follows:

- Check
- Cash (Receipt will be provided)
- Credit Card (Excluding payment in full)
- Automatic Credit Card Deduction (Credit Card authorization required)
- Phone Payments (Credit Card only)

In the event of any financial difficulty, it is the parent(s)/guardian(s) responsibility to communicate directly with the Principal. Should payment not arrive by the designated grace period, the account will be considered delinquent. Should a check be returned from the bank, an NSF fee of \$25.00 will be added to your account. Any tuition payment that is deemed delinquent will be subject to the Delinquent Tuition Policy process as listed in the Family Handbook. Families having serious difficulties meeting the tuition or other contractual obligations are expected to communicate with the Principal in a clear and timely manner. All family accounts that are two-months behind at the end of the trimester, will not be readmitted into school until the balance is paid.

All families of an oldest and only student in the 8th grade must select the 10-month plan for tuition. All financial responsibilities must be cleared by **May 20, 2016.**

As part of the 2015-2016 Enrollment Contract, it is mandatory for each family to participate in fundraising. Each family is required to earn a profit for the school equaling \$500.00. - EScrip / SHARES / TARGET Families will continue to participate in earning profit through EScrip (Online shopping), SHARES points (Shopping at Food Maxx & Lucky), and TARGET (Debit or Credit Card sales designated profit to St. Bede Catholic School) (Online registration is required for this option)
- World's Finest Chocolate Bar Sales SEPTEMBER St. Bede Catholic School will kick off the World's Finest Chocolate Bar Sale. (Profit of 50% excluding shipping costs) (A separate form will need to be completed for this option.)
- Jog-A-Thon OCTOBER Our annual Jog-A-Thon will happen on 10/23/15. All proceeds from the Jog-A-Thon will go directly towards your Fundraising requirement. (A participation form and sponsor form will need to be completed for this option.)
- Christmas Gift Shop NOVEMBER We will kick off this fundraiser in late October and sell through November. Profits of 50% (Excluding shipping and sales tax) will be applied towards the fundraising requirement.

Mandatory Participation:

Initial

It is mandatory for parent(s)/guardians to attend the following: Student Registration Night in May, Back to School Night in September, Parent/Teacher Conferences in October, and the State of the School Report held in the spring. It is mandatory for all students to attend the following: The Christmas Concert in December, the Spring Concert, and the annual grade level Sunday Masses as designated. Each family is required to purchase or sell **one ticket** for our **Crab Feed on Sat, January 9, 2016**.

SERVICE HOURS POLICY

A minimum of thirty (30) hours, (fifteen (15) for one-parent families – as approved by the Principal) must be completed between <u>June 1, 2015 and May 31, 2016.</u>

A mandatory eight (8) hours of service must be earned at the St. Bede Parish Festival the third weekend in May. (These hours are included in the total hours)

All volunteers that work within the school or attend field trips must be cleared through LiveScan fingerprinting (Diocese of Oakland) as well as completing the Safe Environment Online Training or at a live seminar.

Service hours may not be transferred to another school family. Hours earned will be calculated by completing an approved service hour coupon, or being listed on a volunteer sign in sheet. Families that are a no-show for hours that they have signed up for and do not give at least 24-hours (confirmed) notice of cancellation, will be charged \$25.00 for each hour they were scheduled to volunteer. Service hours that are not completed at the end of the school year will be charged at \$25.00 per hour. (Festival hours not worked are charged in addition)
