Registration Requirements

A child entering Kindergarten, by law, needs to be five years old by September 1st.

At Holy Name School, we require the following documentation for students entering any grade:

- Birth Certificate
- Immunization record
- Previous year's report card, if applicable
- Baptismal certificate (Catholics only)

Immunizations

In order to better understand your child's health status and to meet the Massachusetts Department of Public Health regulations, we require information about your child's past and present health history and immunization status. You must complete this information before we can allow your child to enter the Holy Name School.

In accordance with Massachusetts state law, we require students to be in compliance with the required immunizations. New students should also provide a completed physical examination form:

- **DPT/DTaP**
 - Pre-school: 4 or more doses
 - Kindergarten: 5 doses
 - Grades 1-6: 4 or more doses (or 3 or more doses of Td)
 - Grades 7: 4 or more doses (or 3 or more doses of Td; plus 1 dose of Tdap)
- **OPV/IPV (polio):**
 - Pre-school: 3 or more doses
 - Kindergarten: 4 doses
 - Grades 1-7: 3 or more doses
- **MMR (measles, mumps, rubella/German measles):**
 - Pre-school: 1 dose
 - Kindergarten-Grade 7: 2 doses
- **Hepatitis B:**
 - Pre-school – Grade 7: 3 doses
- **Hib (haemophilus influenza type B):**
 - Pre-school: 1-4 doses (depends on age of child at initial dose)

- **Varicella (chicken pox):**
 - Pre-school: 1 dose
 - Kindergarten: 2 doses
 - Grades 1-6: 1 dose
 - Grades 7: 2 doses

- **Tb (tuberculosis screening):**
 - Pre-school-7: TB Risk Assessment (one documented risk assessment from anytime since birth)

- **Lead Screening:**
 - Pre-school or Kindergarten entry: Documentation of blood lead screening.

These requirements allow for medical reasons and religious beliefs. If your child is exempt from immunizations, we may remove him/her from school during an outbreak.

Tuition – 2015-2016 School Year

Kindergarten through Grade 8 - \$3,675 Plus a Scholastic / Technology Fee of \$250

Pre-Kindergarten – Full Day - \$4,375 Plus a Scholastic / Technology Fee of \$250

Pre-Kindergarten – Half Day - \$3,375 Plus a Scholastic / Technology Fee of \$250
