- A. Mr. Stahl updated the Board regarding the elementary construction project. He noted that the contractor is trying to get the addition "under decking" prior to the arrival of winter, credits had been received for various items, and billings had been accurate to date.
- B. Mr. Koba reported that the musical this year would be "All Shook Up."
- C. Mr. Buchsen/Mr. Slonka reported that the stadium field condition was excellent despite the large amount of rain received due to Hurricane Sandy.
- D. Mr. Buchsen requested that the Board consider contracting with Epic Communications (Rosemary Enos) to assist with e-rate reimbursement; the fee would be 10% of the reimbursement received. This item will be included on the regular meeting agenda for consideration. Mr. Buchsen then reported that the WAN contract with I. U. 08 expires on June 30, 2013, and he had received a five-year proposal from Atlantic Broadband for less than half the current cost and a much faster speed. He also stated that he had been in contact with four vendors to obtain information on updating the District's website, and the hosting cost may be eligible for reimbursement through e-rate.
