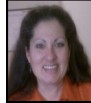

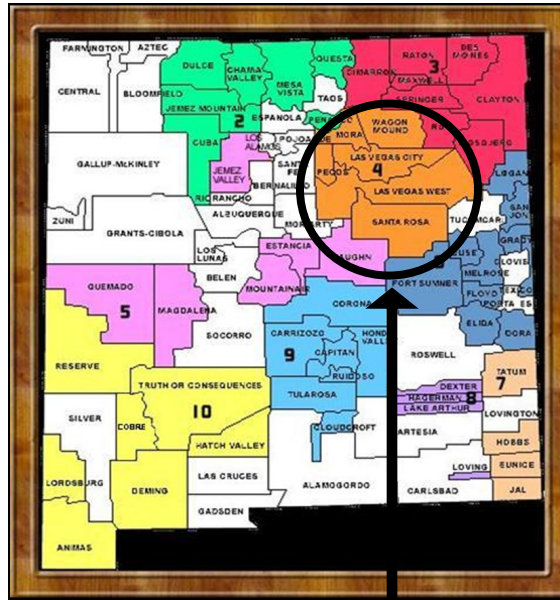

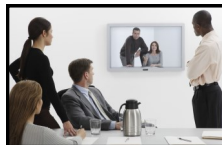

Process for Training, Technical Assistance, and Supports

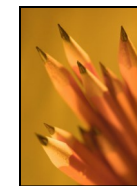
- ▶ NEREC services begin with an introductory visit to your district or school administrative office to discuss your needs for training, technical assistance and support.



Service Plan ▶ A proposed service plan will be developed and promptly returned

to you in the form of a simple contract specifying goals, scope of work, timelines and a detailed breakdown of costs.

- ▶ Training, technical assistance, report and document preparation, and resource development will be provided on-site or via distance technology when appropriate.



Hands-On Support

- ▶ Ongoing technical assistance and support will include hands-on work on-site with teachers and staff to improve classroom effectiveness, administrative functions, and the school environment.
