
District Overview

What is an override?

An override allows school district voters to approve additional funding for operational expenses. The override would allow the district to exceed its budget by 15 percent. If approved, the election authorizes an increase for seven years, but the override must be renewed every five years to maintain full funding.

Has the district been operating under an override?

Queen Creek Unified School District was operating with an override from 2004-2015. The override election for 2015-16 failed by 300 votes.

What does the override pay for?

The override funds teaching positions, academic programs, employee compensation and reducing class sizes.

What does the override cost me?

For your personal tax impact, check your tax bill. The owner of an average home in the district will pay \$244 a year, or \$20 per month.

How will the override appear on my ballot?

On the ballot it is referred to as a "budget override"

What is the difference between a bond and an override?

A bond provides the district additional funding to use for capital items such as new buildings, additions or renovations to buildings, school buses, equipment and technology, Queen Creek voters last approved a bond in November 2014.

An override is for day-to-day operational expenses including salaries and benefits, classroom supplies, utilities and transportation. Queen Creek voters approved the last override in November 2007.

How long does an override last?

Once approved, the override lasts for 7 years, with full funding for 5 years. Should constituents not pass another override in the 5th year, the override phases out over the next two years.
