## **Parental Involvement**

### **PARENTAL INVOLVEMENT**

The District's Title I, Part A program shall be planned and implemented with meaningful consultation with parents of participating students.

The District, in receipt of Title I, Part A funds, shall develop a written parent involvement policy jointly with and distribute to parents of participating children. The policy shall be incorporated into the District's plan developed under 20 U.S.C. 6312. The policy shall also establish parent involvement expectations, and describe how the District will:

- Involve parents in the joint development of the plan under 20 U.S.C. 6312, and the process of school review and improvement under 20 U.S.C. 6316;
- Provide the coordination, technical assistance, and other support necessary to assist participating schools in planning and implementing effective parent involvement activities to improve student academic achievement and school performances;
- Build school and parent capacity for parental involvement as described under 20 U.S.C. 631(e);
- Coordinate and integrate parental involvement strategies under Title I, Part A with parental involvement strategies under other ESEA programs;
- Conduct, with the involvement of parents, an annual evaluation of the parental involvement policy and use of the findings as described at 20 U.S.C. 6318(a)(2)(E); and
- Involve parents in the activities of the schools served.

Parents shall be notified of the policy in an understandable and uniform format and, to the extent practicable, provided in a language the parents can understand. Such policy shall be made available in the local community and updated periodically to meet the changing needs of the parents and the school. *No Child Left Behind Act, 20 U.S.C. Sec. 6318*

### **PARENTAL INVOLVEMENT PLAN**

Annually, parents of Title I students and District personnel work jointly to develop a written parental involvement policy, setting forth the expectation for parent involvement. The policy shall be reviewed annually by parents and staff and appropriate revisions made.

### **COORDINATION OF TECHNICAL ASSISTANCE**

The Title I District office shall coordinate and provide technical assistance to participating schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance.

### **BUILDING SCHOOL AND PARENT CAPACITY FOR INVOLVEMENT**

Parents of students who attend Title I schools may contact their child's campus for information related to parental involvement activities.

### **COORDINATION OF PARENTAL INVOLVEMENT STRATEGIES WITH ESEA PROGRAMS**

Parents shall be informed of educational opportunities offered through the District.

### **PARENTAL INVOLVEMENT EVALUATION**

Each year the Title I parental involvement evaluation is presented in a meeting to administrators, teachers, and at least one parent from the Title I District. Meeting participants shall have an opportunity to provide input.

### **INVOLVE PARENTS IN SCHOOL ACTIVITIES**

Opportunities shall be provided to parents to become involved in their child's education.
