SANTA CRUZ VALLEY UNION HIGH SCHOOL DISTRICT #840 GOVERNING BOARD MEETING MINUTES – March 12, 2020

DATE/TIME/PLACE

The Santa Cruz Valley Union High School District Governing Board of Education held a Regular Board Meeting beginning at 6:00 PM on Thursday, March 12, 2020 in the Santa Cruz Library, Community Room which is located at 1000 N. Main Street in Eloy, Arizona.

CALL TO ORDER

Ms. Flores called the regular meeting to order at 6:06 pm and led the audience in the Pledge of Allegiance.

THOSE PRESENT

Elizabeth Flores, President, Anna Bell Sauceda, Vice President, Richard Reyes, Member, Orlenda Roberts, Superintendent, Dr. Oranté Jenkins, Principal and Sherry Eisler, Administrative Assistant were present. Thomas Gil, Member, Emilio Ysaguirre, Member, Debi Tabeling, Business Manager were absent.

REGULAR MEETING

RECOGNITIONS

Mrs. Roberts announced that she had the recognition certificates for the team and coaches. However, they would be disturbed to the wrestling team and coaches at the community event which would be held that evening at 7:15 pm at the SC gym.

CALL TO THE PUBLIC

There were no requests from the Public to address the Governing Board.

MONTHLY REPORTS

Ms. Flores asked about the cleanness of the classrooms. Mrs. Roberts explained that she had met with the staff members who submitted the work orders plus met with the custodial staff to

look at the classrooms and discuss the situations. Mrs. Roberts explained that she had asked the staff members to notify her again if their classrooms continued to not be cleaned appropriately, and that she has not been contacted further by the staff. However, she will again follow up with the staff. Mr. Reyes commented that there is a problem with keeping bathrooms clean in the front office. Mrs. Roberts stated that she had also addressed this issue with the head of the custodial staff and the director of maintenance.

BUSINESS ITEMS

1. Discussion/Approval/Disapproval to consider and, if deemed advisable, to adopt a Resolution authorizing the Issuance and Sale of School Improvement Bonds of the District and adopting certain Post-Issuance Continuing Disclosure Procedures.

Mrs. Roberts informed the governing board that there were two phases for the school improvement bond and this was for the second half of the bonds which would be sold. She introduced Mr. Geil from Gust Rosenfeld, who stated that the process will be the same when the bonds were sold as for the first phase. Mr. Reyes asked if a date has been set for a start for the second phase of the projects. Mr. Geil informed the board that the process for selling the bonds would start in four to six weeks, and will not exceed over 12 years with the interest rate not to exceed 4.75 percent. He went on to say there have been changes in the market and the interest rate may be as low as 3 percent but would not be higher than the 4.75 percent. Mrs. Sauceda asked what the next sets of projects were. Mrs. Roberts stated the auditorium, lighting for baseball and softball fields, buses and resurfacing the tennis counts. Ms. Flores requested an updated project list be provided to the board. Mr. Reyes asked for a update on the air-handlers. Mrs. Roberts stated that they are working with the Schools Facilities Board (SFB). Mrs. Sauceda asked how much the bond would be. Mr. Geil responded by saying \$2,675,000.00 which will be the principal and there would be some cost of Issuance along with consulting fees.

Mrs. Sauceda MOVED to accept to consider and, if deemed advisable, to adopt a Resolution authorizing the Issuance and Sale of School Improvement Bonds of the District and adopting certain Post-Issuance Continuing Disclosure Procedures, with a SECOND by Mr. Reyes.

2. Discussion/Approval/Disapproval of the FY2019-2020 Revised #2 Budget

Mrs. Roberts explained to the board that Ms. Tabeling was able to increase the maintenance and operation funds by \$108,977.00 due to an increase in the Special Education student count which had not been updated by Arizona Department of Education when the first revision was done and that CAVIT students were now able to be counted by an additional .25 percent.

Mrs. Sauceda MOVED to accept the FY2019-2020 Revised #2 Budget, with a SECOND by Mr. Reyes.

SUPERINTENDENTS ITEMS

1. Monthly Report

Mrs. Roberts asked the board if they had any questions regarding her report. Mr. Reyes inquired about the board being informed about the next school years budget. Mrs. Roberts stated she would work with Ms. Tabeling and make recommendations to the board. It was agreed there would be continuous updates either at a monthly board meeting or email.

Mrs. Sauceda stated that she saw two prisoners working between Santa Cruz and Curiel last Wednesday with no supervision. The city was called and a van picked up the prisoners. It was discussed that no schools were notified that prisoners were working by the schools with students on campus.

Mr. Reyes commented that the area by the solar panels has equipment stored and would like to see it removed as quickly as possible. Mrs. Roberts stated that Mr. Longoria is planning on using the prisoners to help remove the equipment. Mrs. Sauceda inquired about the equipment that is stored underneath the stadium bleachers and Mrs. Roberts stated Mr. Longoria will be working on this area also. Mr. Reyes recommended the storage items be placed at a better location.

Ms. Flores asked if it was a full-time position, Mrs. Roberts stated no, it would be three to sometimes four days a week. She went on to say the pay would be less than current contracted position. Mr. Reyes commented it was determined by the board, in a previous board meeting, not to hire due to the budget cut backs. There was a detailed discussion regarding the budget and personnel. Ms. Flores asked all members of the board be provided the current pay for the position under contract with the vendor. Mrs. Roberts stated she would provide the information to the board along with a salary schedule for the position.

Mrs. Sauceda MOVED to approve to replace the position of Special Education Administrative Assistant which is currently under contract, with a SECOND by Ms. Flores with the condition that the current salary is provided to the board along with a salary schedule before the position is advertized.
