SANTA CRUZ VALLEY UNION HIGH SCHOOL DISTRICT #840 GOVERNING BOARD MEETING MINUTES – November 14, 2019

REGULAR MEETING

DATE/TIME/PLACE

The Santa Cruz Valley Union High School District Governing Board of Education held a Regular Board Meeting at 6:00 PM on Thursday, November 14, 2019 in the Santa Cruz Library, Community Room which is located at 1000 N. Main Street in Eloy, Arizona.

CALL TO ORDER

Mrs. Flores called the regular meeting to order at 6:02 pm and led the audience in the Pledge of Allegiance.

THOSE PRESENT

Elizabeth Flores, President, Anna Bell Sauceda, Vice President, Thomas Gil, Member, Richard Reyes, Member, Emilo Ysaguirre, Member, Orlenda Roberts, Superintendent, Debi Tabeling, Business Manager, Orante Jenkins, Principal and Sherry Eisler, Administrative Assistant.

CALL TO THE PUBLIC

Mrs. Pat Tarango addressed the Governing Board regarding students struggling to achieve a 90 % passing grade with the IXL Enrichment program. She stated she thought it was a good enrichment program but that the expectation was set too high since some students are passing other classes but not the enrichment program.

Mr. Tad Roberts, President of the Casa Grande Optimist Club, presented a check to SC Band Director, Josh White, for \$500.00. He went on to say that one of their Optimist members was tremendously impressed with Santa Cruz's band which he has seen at an event and the club wanted to help the band in some matter. To stay neutral, Mr. Roberts stated that he asked the member to speak directly to Mrs. Roberts, SC Superintendent. After a meeting of the club at which this was discussed, the members requested that a donation be presented to the SC band. Mr. Roberts stated that the Optimist Club has never given donations outside of their community which is Casa Grande. The donation to the SC Band is the first one to be approved.

Mrs. Roberts congratulated Mr. White for his hard work as a band director and for the excellence demonstrated by his students.

MONTHLY REPORTS

Ms. Tabeling informed the board members that in the next two weeks the company would start repairing the solar panels. She went on to say that she had contacted Mr. Eddy requesting that he remove the damaged fencing, which would be moved by the weekend. Mr. Ysaguirre commented that earlier in the week he had noticed a repair person in the area. Ms. Tabeling added that they will remove the damaged equipment after the repairs are complete.

Mr. Gil asked if next year the school would be asking the community to vote again for an override. Ms. Tabeling responded by stating, "Yes, and we will have to ask for a 10% override of the schools budget. Mrs. Sauceda asked when would be the earliest election to vote for the override. Ms. Tabeling stated that she had inquired about May but that was rejected by County Elections and that we would not have an all mail-in ballot. It was discussed which ballot approach would be more effective for the override to pass. Mr. Ysaguirre stated that people in Picacho were not informed of where to return the ballot if it was not mailed back to county. Mrs. Sauceda also stated that people were contacting her asking where to take the ballots. She researched and notified Santa Cruz High School and Eloy Intermediate personnel. It was discussed about how to get more people involved to participate on the override committee and strategies to reach out to the community.

Mr. Reyes asked if a work session will be scheduled to discuss where in the budget we will have to decrease. Ms. Tabeling stated yes.

Mr. Reyes asked if the school could appeal the letter grade. Dr. Jenkins stated that he had spoken with Ms. Smith and that there was no means of an appeal. Mrs. Roberts commented that the Arizona Department of Education (ADE) is being extremely strict about appeals.

Ms. Flores asked for the definition of computer defiance. Dr. Jenkins responded by saying that the IT department has installed a program called "Securely" and when a student tries to open a webpage that is inappropriate, it is logged and a report is created which is directed to Mr. Bates and Dr. Jenkins. The student is then contacted and, if necessary, progressive discipline steps may be initiated.

Mr. Reyes asked if the banners were placed in the gym. Mrs. Roberts stated "no" and explained that the lift from Eloy Elementary will not reach. Ms. Tabeling commented that she is working on obtaining a donation to help on the cost of renting a lift. She went on to say that she asked Mr. Longoria to contact the City of Eloy to borrow a lift if they have one that will work. Mr. Reyes stated that he was under the impression that when Mr. Ocampo was working on the banners, specs and lifts were in place and the job needed to be completed. Ms. Tabeling stated it could not be completed due to the floor needing to be protected or the warranty would not be valid. Cost of the lift and the height of the gym wall were discussed in length. It was brought to attention by Dr. Jenkins that the contractor, D.L. Withers, had discussions with Mr. Ocampo about getting the banners on the wall. A discussion was held on the problems with flooding in the gym and the preservation of the gym floor. Mrs. Sauceda asked for clarification about in which area(s) there was flooding damage. Ms. Tabeling explained that the practice gym floor will be replaced. A discussion was held about how the floor was damaged during a recent severe rain storm. Ms. Tabeling has contacted architect Bill Carnell to assist the

district with any necessary reports needed to get a vendor to do repairs on the roof to avoid this type of damage happening again to the floor.

Ms. Tabeling explained to the board that the School Facilities Board approved the IFB on November 6^{th} . She went on to say that they will be working on the auditorium roof and other projects and that this will be a \$600,000.00 project.
