# Minutes of Preceding Meetings

Approved the Minutes of the October 7, 2019 Committee-of-the-Whole meeting and the October 14, 2019 regular meeting as corrected (remove paragraphs 3 and 4 under finance as they are duplicates of paragraph 1 and 2). Motion: L. Drabert; Second: C. Nasto. The motion was unanimously carried.

# Treasurer's Report

Approved the Treasurer's Report for the period ended October 31, 2019 as presented by Mr. Daniel Lane, District Treasurer. Motion: J. Stake; Second: K. Hawver. The motion was passed unanimously.

General Fund account balances on October 31, 2019 were as follows: Juniata Valley Bank (JVB) Investment Savings - \$8,201,409.73 and JVB Now Account - \$18,564.29. Receipts since November 1 were \$146,039.24 and expenditures were \$309,663.84 bringing the balance in the general fund to \$8,056,899.42.

October 31, 2019 balances for various accounts were reported as follows: Capital Reserve Investment Fund - \$2,726,305.31; Student Activities Account - \$88,051.05; Student Athletics Account - \$66,012.41; and Cafeteria Account - \$42,295.79.

# **Bill Listings and Payrolls**

### Finance

Approved the Agreement with Beacon Light Behavioral Health Systems for alternative education for disruptive youth services at the Custer City Private School. Motion: K. Hawver; Second: L. Drabert. The motion was unanimously carried.
