Permissions and Acceptable Use Policy

**Introduction:**

The Kindle Fire is a convenient, portable reading device, which is the size of a paperback book and capable of holding numerous books, accessing the Internet, and taking advantage of many educational applications. The chance to use this device is a privilege that we are able to provide to students in this library contingent upon the students using extra caution and responsibility with these devices. Each Kindle Fire is valued at \$200 and each case is valued at \$70. For this reason, we require a parental signature before a Kindle Fire can be assigned to a student.

**Parental Responsibilities and Permission:**

I am authorizing the assignment of a Kindle Fire to my child. I understand that it is to be used as a tool for reading and learning and that my child will comply with the PASD Acceptable Use Policy. I will help ensure the safe and timely return of the Kindle within the loan period of one week. I understand that I am financially responsible for any willful, malicious, or accidental damage to the Kindle Fire as well as any charges resulting from content downloaded to the Kindle. I understand that any lost, damaged, or stolen Kindle and its accessories are my financial responsibility, and that the replacement cost for this equipment is \$200.00 (Kindle Fire) and \$70 (Case). I understand that my child may lose loan privileges of the device if the Kindle is either damaged or not returned in a timely manner. *I understand that a fine of \$1.00 a day will be assessed if the Kindle Fire is not returned on time.*
