

CHS Parking Application – 2016 - 2017

Parking in the student parking lot is by an approved CHS parking application only. At the beginning of the school year for any CHS student who has a valid California Driver's License on a first come, first serve basis while spaces are available. Students who fail to comply with all rules set forth in school policy, and the rules & regulations on the Corcoran High School risk suspension of and/or revocation of their parking privileges. Violation of this application and the rules set forth by the Corcoran Unified School District could result in citation or removal of the vehicle from school ground at the cost of the vehicle owner expense. Only complete forms will be accepted. Students must present their valid California Driver's License, proof of registration and insurance for the parking application to be approved.

NOTE: False information on this application could result in the loss of the parking privilege on the Corcoran High School campus.

Parking Rules & Regulations

Parking in the student parking lot is by approved CHS parking application only. All students who wish to apply for a student parking on the Corcoran High School campus must complete an application. **The approval of a CHS parking application does not guarantee the driver the right to park in the Corcoran High School student parking lot.** Parking in the Corcoran High School student lot is a privilege accompanied by the expectation of responsible behavior on school grounds. The Administration of Corcoran High School may revoke and/or suspend parking privileges at any time if the following school regulations are not followed.

- *Students must drive safely, in accordance with all State and Local Vehicle Code regulations, maintaining a safe speed (5 mph or less) and safe conduct at all times.*
- *Students must park and drive only in designated areas (Student parking lot).*
- *No parking is allowed at any time in driveways, fire lanes, staff or visitor areas, Yellow or Red curbs, or on dirt designated as staging areas for construction vehicles or behind the ag building.*
- *Student vehicles must park facing into spaces.*
- *The parking permit **must be visible** at all times through the front window to be valid.*
- *Permits **MAY NOT** be transferred from one student's vehicle to another.*
- *Only one parking permit may be given per family.*
- *Security for parked vehicles requires that no student is to be in the parking lot during the school day. Do not use your vehicle as a locker. Do not loiter in parking lot.*

IMPORTANT INFORMATION for 2015-2016

- *If a temporary pass is needed, in cases of car repair or need to switch vehicle with a parent, it is the responsibility of the student to go to the main office to acquire a temporary parking pass prior to the start of school. If a valid temporary permit is not posted on the dashboard of the vehicle, the vehicle could be towed or cited per Local Vehicle Code regulations*
- *Students ARE NOT to be loitering in the parking lots during school hours. Failure to follow this rule will result in a temporary suspension of the privilege to park in the Corcoran High School parking lot.*
- *Any Corcoran High School student caught on school grounds or CUSD property (during and after school hours, sports events or extracurricular activities) in direct possession of (personal possession, possession of or in a backpack or vehicle) controlled substances (alcohol, drugs, tobacco, or other illegal controlled substances) may forfeit their right to park in the Corcoran High School student parking lot. First Offense may result in the loss of the parking privilege for one calendar month. Second Offense or more may result in the loss of the privilege for the remainder of the semester, or one calendar month, whichever is longer. Discipline as outlined in the Corcoran High School Student Handbook will also apply along with California Penal, Health and Vehicle Code regulations.*
- *Student drivers will be responsible for the behavior of their passengers and may lose parking privileges for adverse behavior.*
- *Students will treat fellow students and all Corcoran High School Employees with respect and courtesy at all times in accordance with the Corcoran High School student handbook. Student drivers may lose parking privileges for adverse behavior per the Corcoran High School student handbook.*
- *Parking permit is to be affixed to the inside, lower corner of the front window on the driver side of the vehicle listed on the parking application. Permits are issued to a specific vehicle, not the student.*
