School Description and Mission Statement (Most Recent Year)

Kings Lake Education Center is an alternative education site that allows students the opportunity to complete their high school education and graduate with a diploma in an innovative setting. The campus houses the district's Continuation High School; district Independent Study Program, Corcoran Academy and Corcoran Adult School. Kings Lake Continuation High School serves students in grades ten through twelve, and the District Independent Study Program and Corcoran Academy serve students from grades K-12, although most students in those programs are in middle school or high school. The Corcoran Adult School is open to adults 18 years of age or older that are looking for ways to expand their knowledge and gain a competitive edge. Whether students decide to earn a High School Diploma, sharpen their computer skills, acquire citizenship or learn English, we are here to help them pursue their special interests and reach their goals. The Adult Education program employs four part time teachers, one that teaches adult students on independent study, one teaches English as a Second Language (ESL), one teaches our Technology/Computer Skills Course and one teaches our Citizenship Course. All programs at Kings Lake Education Center are academic in nature with classes' varying in enrollment each semester with individual instruction available as the most common mode of instructional delivery. Although additional information is included above, this accountability report is for the continuation high school.

The Mission of Kings Lake Education Center is to increase student achievement, provide safe schools and promote a positive climate.
