In consideration of being given the opportunity to participate in the IICSN Athletics Program including schedule, supervised group activities during the school term, I for myself, my parental representatives, assigns, heirs, and next of kin. This IICSN Athletics Program is a program developed to foster the knowledge, skills, and physical development for students. As a member of this group, it is my responsibility to:

- 1. Acknowledge, agree and represent that I understand the nature of skills, coordination, rules, and sportsmanship and that I am qualified, in good health, and in proper physical condition to participate in such activity.
- 2. Fully understand that the participation in sports involves risk and dangers of serious bodily injury, including permanent disability, paralysis, and death (Risks). These risks and dangers may be caused by my own actions, or inaction, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the Releasee names below. There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the IICSN Athletics Department and games and practices associated with this activity. I also FULLY ACCEPT THE RESPONSIBILITY OF ENSURING I HAVE PROPER SAFETY EQUIPMENT ON AT ALL TIMES WHEN PARTICIPATING IN THE PRACTICES AND COMPETITIVE GAMES associated with being on an IISSN sports team.
- 3. Agree and warrant that I will examine and inspect each activity in which I take part as a member of the Innovations International Sports League and that if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the activity and will refuse to take part in the activity until the condition has been corrected to my satisfaction.
- 4. Hereby release, discharge, and covenant not to sue Innovations International Charter School of Nevada, the administrators, directors, agents, officers, volunteers, and employees any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the activity take place, (each considered one of the Releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the release or otherwise, including negligent rescue operations. I further agree that if, despite this release and waiver of liability, assumption of risk and indemnity agreement, I, or anyone else on my behalf, makes a claim against any of the Releasees, I WILL INDEMINIFY, SAVE AND HOLD HARMLESS each of the Releasees from my litigation expenses, attorney fees, loss, liability, damage or cost which any may incur as a result of such claim, to the fullest extent permitted by law.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
